DIRECTIONS FOR USE

BigSweetYield can be applied to more field and row crops. BigSweetYield is designed for soil application and for foliar use. Apply directly to soils or inject through irrigation systems. Application rates vary by crop or situation. Mixing with irrigation water for field storage is generally not recommended. Products blended with irrigation water should be used immediately and not stored for prolonged periods.

BigSweetYield is an auxiliary soil and plant substance and is designed for soil and foliar use to enhance plant growth, earlier bloom and flower formation, as well as to stimulate microbial propagation.

SOIL APPLICATION RATES

BigSweetYield may be applied pre-plant, as a starter, side dress, or fertigated - dilute with water to ensure uniform distribution.

FOLIAR APPLICATION RATES

ALL CROPS: Apply 1 lb (16 oz) per acre with the appropriate dilution for adequate coverage. Repeat applications may be beneficial.

MIXING INSTRUCTIONS

1. Partially fill tank with water and start agitation.
2. Add BigSweetYield slowly to the circulating mix. Mix thoroughly.

GENERAL INFORMATION

BigSweetYield will be influenced by various soil and environmental conditions and should be applied under conditions of optimum plant growth. Optimum conditions are defined as adequate humidity, moderate temperatures and adequate soil moisture. Optimum conditions for most crops generally occur during morning or late evening hours.

Use caution when handling. BigSweetYield may not be compatible with all fertilizer mixes and / or pesticides on the market. Always check compatibility with other products prior to use. Keep out of reach of children.
