Effective Rate

Starter or Side dress - Apply 1 to 2 pints per acre or 1.173 L (1,173 mL) to 2.345 L (2,345 mL) per hectare. Mix with sufficient volume of water to achieve desired coverage.

Foliar application - Apply 1 to 2 pints per acre or 1.173 L (1,173 mL) to 2.345 L (2,345 mL) per hectare.

Broadcast - 4 pints per acre or 4.693 L (4,693 mL) per hectare. Mix with sufficient volume of water to achieve desired coverage.

For crop specific application rates refer to Application Methods, Rates & Frequency table provided or contact your product representative.

Storage:

Store product in original container with cap tightly secured. Store in a cool area (40° - 110° F | 4° - 44° C) out of direct sunlight.
